Book reviews

A Colour Atlas of Clinical Parasitology

By TOMIO YAMAGUCHI. Pp. IX+293, illustrated. Wolfe Medical Publications, London, 1981. £35.00.

The first thing to say about this atlas is that the standard not only of the photography but of the presentation of specimens is quite remarkable and almost certainly unsurpassed. Anybody who sees it will want to own a copy, but one must consider who will benefit, and how.

The subject of the atlas is parasites and their vectors, but there are also some clinical, histological and EM illustrations, and apposite brief notes and line drawings. There is no general text, and the atlas must therefore be regarded as a supplement to a standard reference book. The subject matter is wide-ranging but not quite comprehensive, being strong on Far Eastern parasites with South America well represented and Africa rather less so. All phases of the life cycles are illustrated. Some of the pictures of malaria parasites appear not to be quite up to the very high general standard.

It is a pity to have to say that the arrangement is probably misconceived. It is according to symptoms, e.g. respiratory, abdominal pain, and in consequence some parasites are dealt with under 4 or 5 headings, a disadvantage that outweighs any small benefits. One would have liked to see technical notes on the preparation of the superb specimens.

In conclusion this atlas is something of a luxury, but a worthwhile one for laboratory workers and others who want to know what parasites ought to look like. For those with £35.00 to spare it is good value.

A Colour Atlas of Tropical Medicine and Parasitology

By W. PETERS and H. M. GILLES. 2nd edn. Pp. 400, illustrated. Wolfe Medical Publications, London; Year Book Medical Publications, New York, 1981. £22.00.

The Wolfe colour atlases now have an established place in

medical libraries. This second edition of the atlas of Tropical Medicine and Parasitology appears four years after the first. The major part of this book is given over to a series of excellent illustrations of endemic diseases of the tropics and sub-tropics, their geographical distributions, and the pathogens concerned. Most are infectious diseases but a number of non-infectious diseases including Burkitt's lymphoma, snake bite, sickle cell anaemia and protein-energy malnutrition, are also discussed. At the back of the book a series of diagrams and tables illustrate parasite life cycles, prevalences of common parasitoses, comparative details of genera, etc. The cover of the book now has a protective coating that will repel marking by frequent handling and the book is well bound. Doctors with a variety of specialist interests will need to refer to this book occasionally and so hospital libraries should have a copy. Physicians who deal with tropical and infectious diseases will probably want to buy a copy of their own. Only one disease, smallpox, has been eradicated between the publication of the first and second editions and it is unlikely that any other tropical disease will disappear in the near future so that diagnosis of tropically acquired diseases will continue to be important. This volume is a valuable source of information to practitioners.

Diagnostic Bronchoscopy

By PETER STRADLING. 4th edn. Pp. xii+159, illustrated. Churchill Livingstone, Edinburgh, London, Melbourne and New York, 1981. £30.00.

This book remains unchallenged as the most authoritative and beautifully produced account of the art of bronchoscopy. It contains 190 full colour plates illustrating the normal and a vast range of abnormal findings. In this new edition all the colour plates have been replaced with new ones of high

Postgraduate Medical Journal: Notice to Contributors

Typescripts. Two complete copies should be sent to the Editor, Postgraduate Medical Journal, Chandos House, 2 Queen Anne Street, London W1M 9LE. Papers should be typewritten on one side of the paper only, with a 1½ inch margin, and the lines should be double spaced. The paper should bear the name of the author(s) with their degrees and the name of the laboratory or research institute where the work has been carried out. The full address of the principal author should be given as a footnote.

The principal author must ensure that any co-authors listed agree to submission of the typescript. Any written or illustrative material which has been or will be published elsewhere must be duly acknowledged and accompanied by the written consent of the authors and publishers concerned.

Arrangement. Papers should be divided into: (a) Summary; (b) Introduction; (c) Materials and methods; (d) Results; (e) Discussion; (f) Acknowledgments; (g) References.

References in the text. These should be made by giving the author's surname, with the year of publication in parentheses. When reference is made to a work by three authors all names should be given when cited for the first time, and thereafter only the first name, adding *et al.*, e.g. Smith *et al.* (1958). The '*et al.*' form should always be used for works by four or more authors. If several papers by the same author and from the same year are cited, a, b, c, etc., should be put after the year of publication, Smith *et al.* (1958a).

All references should be brought together at the end of the paper in alphabetical order giving (a) name(s) of all the author(s) "*et al.*" not acceptable here; (b) year of publication in parentheses; (c) title of paper in its original form; (d) title of journal in full, underlined; (e) volume number, underlined; number of first page of article. References to books and monographs should include (a) name(s) and initials of all author(s) or editor(s); year of publication in parentheses, (b) title, underlined; (c) edition; (d) page referred to; (e) publisher; (f) place. *Authors should ensure that the listed references correspond exactly to those in the text.* Authors are responsible for the accuracy of their references.

Standard usage. The *Concise Oxford English Dictionary* is used as a reference for all spelling and hyphenation. Verbs which contain the suffix *-ize* (*-ise*) and their derivatives should be spelt with the *z*. Statistics and measurements should always be given in figures, i.e. 10 min, 20 hr, 5 ml, except where the number begins the sentence. SI units should be used wherever possible. Papers should be written in the third person.

Figures. In the text Arabic numbers, e.g. Fig. 3, should be used. They should be marked on the backs with the name(s) of the author(s) and the title of the paper. The top of each figure should be indicated with an arrow on the reverse side. Each figure must bear a reference corresponding to a similar number in the text. Photographs and photomicrographs should be unmounted glossy prints and should not be retouched. Line diagrams should be on separate sheets; they should be drawn with black Indian ink on white paper and should be twice the size of the final reproduction. The originals of line diagrams, prepared as described above, may be submitted in photographs of similar size. The legends of all figures should be typed together on a single sheet of paper headed 'Captions to Figures'.

Tables. These should be on separate sheets. The main heading should be in capitals with an arabic number, e.g. TABLE 2. Each table must have a caption.

Page proofs will be submitted to the senior author for minor corrections and should be returned to the Editor within 3 days. Major alterations to the text cannot be accepted.

Offprints. These may be purchased if ordered on the form which will be sent to the senior author with the proofs.
