

the growing skull, and on the course of foetal neural injuries (especially by radiation), deserve special mention. In comparison, the psychiatric section is by no means as comprehensive, although the specific subjects treated are useful and informative. The inclusion of an account of the clinical psychologist's methods of evaluation is an outstandingly original feature in a textbook of this calibre, and the whole work is a distinct contribution to specialist literature.

The latest volume in this valuable series again contains a great deal of valuable information.

There are 21 distinguished authors and each has produced a brief review of the allotted subject of some 15 pages, with a list of references. Several are again of outstanding interest—e.g., Protein Malnutrition, by B. S. Platt, Fat Metabolism by A. C. Frazer, Nucleo-proteins in Cell Structure by J. N. Davidson and the Chemistry of the Por-

phyrias by C. H. Gray, and many others.

Those who look to this annual volume for a series of short authoritative monographs on recent work will be well satisfied with this one.

MEDICAL WRITING: M.D. INTERNATIONAL SYMPOSIA No. 2

By H. E. SEGERIST, H. SELYE, H. CLEGG, W. C. ALVAREZ, and F. MARTI-IBANEZ. Pp. 66. New York: M.D. Publications Inc. 1956.

For some time it has been apparent that the standard of articles submitted for publication in medical journals has been too low, and that both language and style have suffered from the current conventional use of the passive voice and from ill-chosen high sounding words and phrases which give the impression of lack of understanding.

The experienced authors and editors who have written the essays which form this symposium offer good advice on the assessment of material for, and composition of, a proposed article, and on the acquisition of a pleasing style, stressing the need for clarity and lucidity. One hopes that prospective authors will find time to read these papers which are beautiful examples of the art of writing.
